

## A Record Year for JOURNEYS

The 2022-23 fiscal year was a rousing success for JOURNEYS | The Road Home! This year, we moved into our brand new building which allows us to serve more clients in a more effective way. This past fiscal year, JOURNEYS was able to get **181 people out of homelessness!** 


After a slight drop-off in clients before the COVID-19 pandemic hit, clients have steadily increased every year since 2020-21. In fiscal year 2021-22, we served 639 clients. This year, we served **936 clients, boasting a 47% increase in clients** *served!* 

Our 936 clients utilized 50 unique services at the HOPE Center this fiscal year, with a total of **15,843 individual services provided.** The most common service used was **long-term case managment at 5,890**. Among our most common services are housing counseling (3,150), showers (1,464), and street outreach programs (1,373).

Another extraordinary aspect of this year was the opening of our brand new building, the second floor of which is dedicated to our new *Interim Housing Program*, launching November 1, 2023. With this new shelter program, and the relaunch of our PADS Shelter Program on October 1st, we look forward to further serving the community! *Here's to another amazing year filled with HOPE!* 








## Who do we help?


## Survived Domestic Abuse.







Are 65 and older.




Are Under 5 Years Old. Homelessness can affect anyone, but many of our clients belong to particularly vulnerable groups. The percentage represented by each group has remained largely the same, with the exceptions of surviors of domestic abuse and clients with disabilities. Since last year, the former has risen 22.6%, while the latter has declined 5%.

## The HOPE Center

The HOPE Center is the hub of JOURNEYS' dayto-day work. At the HOPE Center, clients can get access to a number of services and necessities, including:

- Self-service laundry

- Resume design, interviewing, and computer skills





## **Emergency Hotel Shelter Program**

The COVID-19 pandemic presented unique challenges to JOURNEYS' operations beginning in March 2020. Since then, JOURNEYS began moving clients into local hotels in order to better protect clients from exposure to the virus.

This past fiscal year, we have maintained the Emergency Hotel Shelter Program with wonderful success. Faith communities and local businesses continue to provide meals to our clients, which are transported by our bus drivers, Bob and Bruce.

## JOURNEYS' Shelter Programs

This coming October, we will be relaunching our PADS Shelter Programs. After a few years of shakiness due to COVID-19, we are now able to continue providing overnight shelter to those we serve. We're so lucky to have so many dedicated faith-communities in the area willing to open their doors to our clients and provide them with warm shelter and a hot meal! We can't wait to work with them again!

In November of this year, we will be launching our Interim Housing Program on the second floor of our building. This brand new housing program is unlike any shelter program in the area, and will operate similar to a PADS site, but will be reserved for special populations of clients who might have difficulties accesing/qualifying for the PADS sites in the area.




